Sub : Meeting on "Shipping & Logistics Services for exports of Textiles to Bangladesh using Inland Waterways"- Through Video Conferencing August 26, 2020 (Wednesday) – 3.00 p.m.

Dear Member,

The Council will be holding a Meeting on "Shipping & Logistics Services for exports of Textiles to Bangladesh through Inland Waterways" with the exporters on **August 26, 2020 at 3.00 p.m through video conferencing.**

As you are aware, Bangladesh is a good export market for Raw Cotton, Yarn and Fabrics for the Indian exporters. India also imports textiles products such as Readymade Garments, Raw Jute and Jute Yarns from Bangladesh.

Currently, around 60% of the exports & Imports between India and Bangladesh takes place through the land routes via Petrapole (India) and Benapole (Bangladesh).

The Government is promoting exports to Bangladesh though the Inland Waterways. The Government has also invested heavily in its Inland Waterways and sees it as a way of improving logistics across the country and with its neighbours.

The objective of the Meeting is to disseminate information related to the facilities available to the exporters to export using the Inland Waterways such as pick up of the cargo at the factory / warehouse, transportation, through Bill of Lading etc. The Meeting would also highlight the benefits of using the Inland Waterways in terms of cost, transit time, Customs clearance etc.

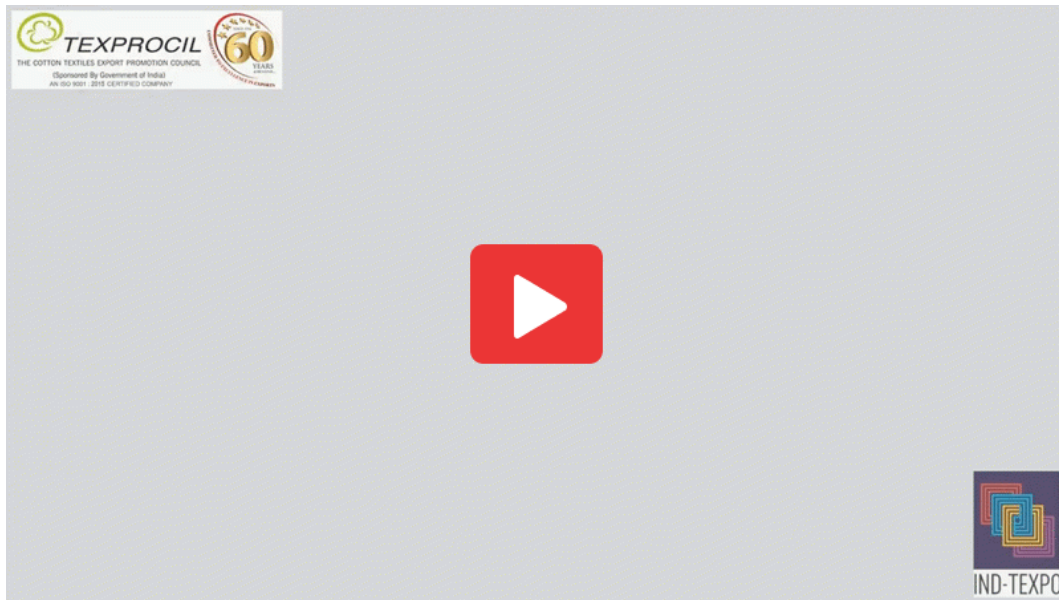
