Many retailers in the USA / Europe are likely to discourage sourcing of textile products made from the raw materials (cotton / cotton yarn) produced in the region.

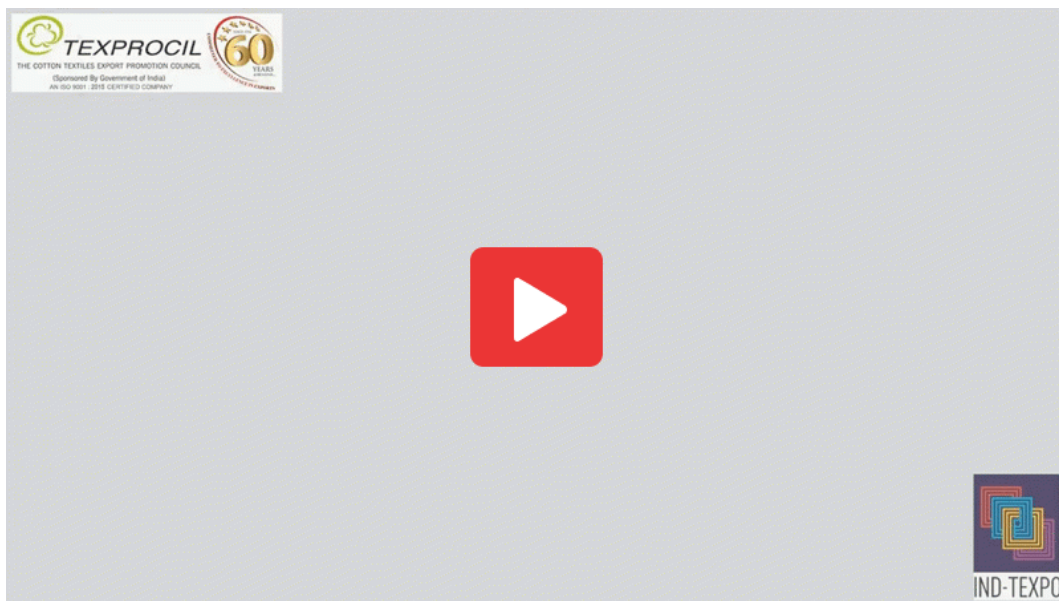
