**Sub : Export of N95 / FFP 2 Masks**

**Dear Member,**

As you are aware, DGFT has issued Notification No.29/2015-20 dated August 25, 2020 to allow export of N95 /FFP2 Masks or its equivalent under the "Restricted Category" i.e. against an Export Licence.

DGFT has now notified the procedure and criteria for export of N-95 / FFP2 Masks vide Trade Notice No. 25/2020-21 dated August 31, 2020.

As per the Trade Notice, a total of one crore units of N-95/FFP2 Masks will be allowed to be exported during August and September 2020 against an Export Licence which will be issued only to **Manufacturer Exporters** on submission of prescribed documents.

**Please note that online applications for export of N 95/ FFP2 Masks should be filed from September 7 to 9, 2020. Applications filed after September 9, 2020 will not be considered.**

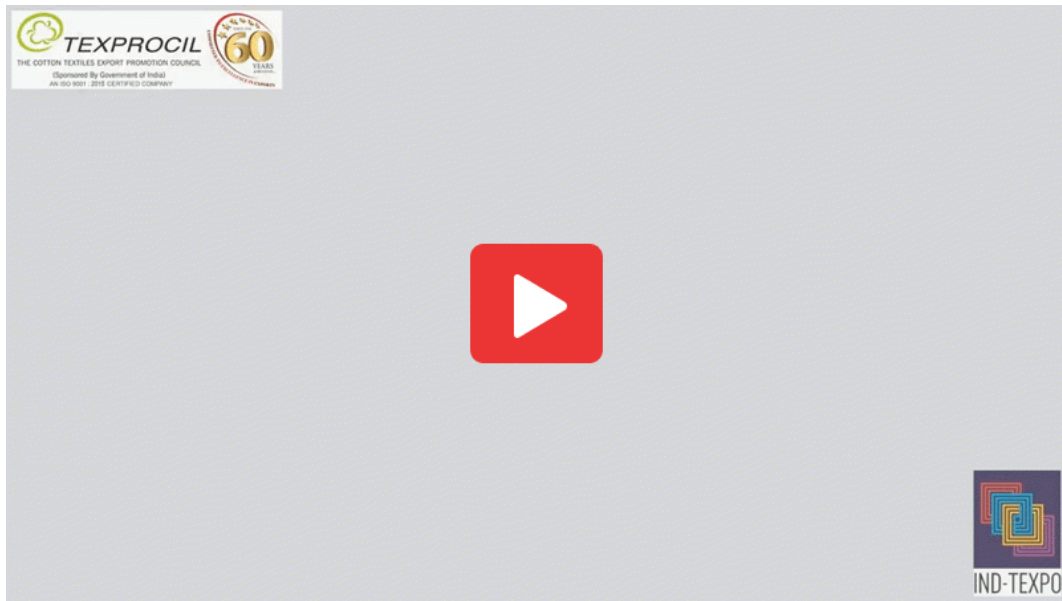
