**Sub : Submission of Annual Statistical Report (ASR) and Monthly Statistical Report (MSR) to the office of the Textile Commissioner**

**Dear Member,**

The Office of the Textile Commissioner vide Public Notice dated 31.08.2020 have requested all the textile mills (MSMEs and Non-MSMEs) to submit Monthly Statistical Report (MSR) and Annual Statistical Report (ASR) to its office. A copy of the Public Notice is enclosed herewith ([click here](#)).

**In this regard, the relevant details are as follows:**

(i) Annual Statistical Report (ASR) for the year ending March 31 is to be filed on or before April 30 every year.

(ii) Monthly Statistical Report (MSR) is to be filed on or before 15th day of the following month. Formats for Annual Statistical Report and Monthly Statistical Reports are enclosed herewith ([click here](#)).

(iii) Details such as installed capacity, employment, consumption of raw materials, production, deliveries and month end stocks of textile items etc are required to be furnished in the ASR and MSR.

## Procedure to be followed:

(i) All textile units should get themselves registered / enrolled online on TSRS port through the link <http://www.txcindia-stats.gov.in/> of the office of the Textile Commissioner. User guide and demo in the said link may be referred to know the steps involved for registration / enrolment.

(ii) On completion of the registration / enrolment process online, the unit / entity will receive TUID, login ID and password on their registered email ID.

(iii) Those units / entities that has already registered in the past and obtained TUID also need to submit the updated ASR and MSR regularly.

(iv) For units engaged in activities under the National Industrial Classification (NIC) code, the NIC- 2008 code is to be mentioned in the ASR and MSR. A copy the National Industrial Classification (NIC) Code-2008 is enclosed herewith ([click here](#)) for your guidance.

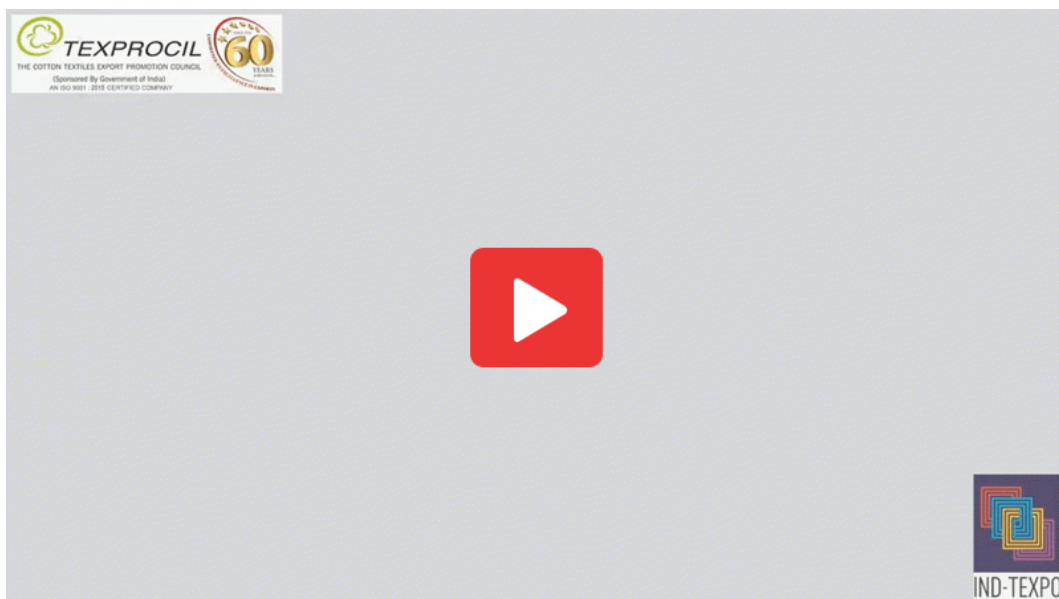
