As informed vide our Circular No. EPS/Cir/106 dated 20.12.2020 , TEXPROCIL will be conducting a Webinar on GST Refunds on Exports, Risky Category Exporters & Latest Amendments in the Foreign Trade Policy / EDPMS" **on December 23, 2020 (Wednesday) at 11.30 a.m to 1.30 p.m.**

An overview

As you are aware, exporters continue to face difficulty in getting refunds of GST on Exports. Further, many exporters have been classified as "Risky Exporters" since the last many months and their IGST / Drawback claims remain suspended. Besides, DGFT have made several amendments in the Foreign Trade Policy since March 2020. Government has also approved a new scheme called as RODTEP. It is in this context that the Webinar is being held.

Objective of the Webinar

The objective of the Webinar is to guide the exporters on various aspects related to exports such as GST Refunds, Risky Category Exporters, Amendments in FTP etc. and also to take suggestions from the exporters on difficulty faced by them in their day to day interactions with the Regional offices of DGFT, Customs, Shipping Lines and the GST Commissionerates so that suitable representations can be sent to the Government.

- Issues related to Refund of GST on Exports under LUT and IGST Refund .

- “Risky Category Exporters” – A detailed explanation of all the aspects related to this issue and the verification procedure followed by the Department and guidance on the “ How an exporter can come out of the “Risky Category Exporters” list.
- Latest Amendments in the FTP related to Advance Authorization & EPCG Authorization Schemes, MEIS and other provisions including the last date of applications under various schemes.
- Changes in the EDPMS of RBI.
- An overview of the recently approved RODTEP scheme.
- Advisory of How to get Refunds such a MEIS, Duty Drawback, ROSL, RoSCTL and GST Refunds on Exports speedily and smoothly without any delay.

The Webinar will also have a “Question & Answer Session” during which participants can seek clarifications / informations on various issues including specific cases.
