chain including farmers, Ginning Units, Spinning Mills, Processing Houses, Weaving Units, Garmenting Units, Home Textile manufacturers and even Retailers and Brands will be involved in a collaborative effort to promote and enhance the value of Indian Cotton across the domestic and overseas markets.

Milestones - Kasturi Cotton Bharat

- Certification protocol has been finalized for standardization of quality for 29 mm and 30 mm cotton, which is under the long staple cotton category. The sampling and testing will be carried out through authorized National Accreditation Board for Certification Bodies and NABLaccredited agencies/labs.
- All the ginners in the country have been empowered to produce Kasturi

The New Year 2024 is upon us — despite the challenging trend seen in exports during the current fiscal year 2023-24, the Indian exporting community has shown a lot of resilience. Despite the challenging global environment, the prospects for trade are marked with hope, challenges, and a lot of uncertainty.

From launching Kasturi Cotton Bharat, integrating Blockchain Technology, taking ahead Global Certificate of Conformity Programme, to coordinating international launch of Kasturi Cotton at 81st Plenary Meeting of ICAC and organising Roadshows across locations in India for Bharat Tex 2024 - the world's biggest ever textiles event being planned in India, it was an eventful year for TEXPROCIL. Some of the key initiatives and achievements in the year 2023 are listed below:

Kasturi Cotton Bharat

Kasturi Cotton Bharat programme of Ministry of Textiles is a first of its kind branding, traceability and certification exercise carried out jointly by the Government of India, Trade Bodies and Industry to promote Indian Cotton. Stakeholders across the supply

Cotton Bharat brand as per stipulated protocol.

- Leading companies and associated Ginning units are being registered for participating in the Kasturi Cotton initiative and 306 units on-boarded till date including 290 Ginners &16 supply chain members.
- First Lot of certified Kasturi Cotton was produced in the month of November 2023 by the Cotton Corporation of India Ltd.
- To provide complete traceability of Kasturi Cotton Bharat across the supply chain, QR based certification technology is being used at each stage of the processing and a blockchain based software platform will provide end to end traceability and transaction certificate. In this regard, a Microsite with QR code verification and Blockchain technology has been developed.
- Kasturi Cotton Bharat website has been launched on the occasion of world cotton day on 7th October 2023. This website provides a digital platform for necessary information and updates on these initiatives and highlights the registration process for ginners to produce Kasturi Cotton Bharat Brand and its processes that make the branded Indian cotton unique.
- Advertisement agency has been finalized for managing the campaign at national and international level. So far, Two Brand Films and Three Celebrity Endorsement Films with Shri Pankaj Tripathi along with Festive

Greeting videos and still photographs has been developed.

81st Plenary Meeting of the ICAC

The Ministry of Textiles hosted the 81st Plenary Meeting of the International Cotton Advisory Committee. The theme of this Plenary Meeting is "Cotton Value Chain: Local Innovations for Global prosperity". The 81st Plenary served as a platform for sharing innovations, benchmarks, practices good and experiences across the globe on productivity, climate resilience and circularity for a vibrant cotton economy. The conference focused on local innovations and cutting edge technologies for sustainability developed locally but have global implications and potential for the prosperity of the cotton value chain touching the livelihoods of millions engaged in production, processing, trade, and fashion and textile industry.

Way Forward

Friends, the data on India's export Yarn/Fabrics/Madeups. of Cotton Handloom Products, etc. have achieved a level of US \$ 7732 million during the period April-November 2023. As compared to the last F.Y. 2022-23, the month-on-month export of cotton textiles during the current F.Y. 2023-24 have achieved a positive trajectory since the month of July 2023.

This positivity is the result of India's newfound flexibility in engaging with its partners in trade. The past successful negotiations with UAE and Australia have paved the way for strategic partnerships with strong economic content. Accordingly, other emerging markets are being targeted to achieve a higher level of export share in the global textiles market.

Amid widespread economic concerns, geopolitical conflicts, and other global disruptions, this year textile companies in all spheres seem to have re-shuffled their operations and business models to maintain the momentum of growth. It is a unique "now or never" moment and companies seem willing to seize it despite the challenges.

Riding on the positivity and hopes of better prospects for export of Indian textiles globally, let me wish all of our member exporters and patrons...

Industry bodies to host global mega textiles event -Bharat Tex 2024- Unveiling the Future of Textiles in India

Tex 2024 Expo is not just an event but a testament to India's commitment to becoming a global textile powerhouse. With innovation, collaboration, and the Make in India spirit at its core, this expo is the embodiment of India's 5F vision - Farm to Fibre to Factory to Fashion to Foreign, making products not just for India but for the entire world, he said adding that India is not afraid of global competition now. He exhorted the industry to build their brands that are globally recognised and simultaneously build India is a brand.

Shri Goyal expressed the hope that the marquee event, Bharat Tex 2024 Expo, would propel the industry's growth and showcase India's potential as a mature, competitive global sourcing destination in the global textile industry. He asked the organizers to make the fair compelling and engaging for the visitors.

Textile Minister also launched the Fair logo, website and video at the event.

"Bharat Tex 2024" is envisaged to be the biggest textile event at the global level, with over 3,500 exhibitors and more than 3,000 Foreign Buyers from 40 countries and 30,000 Domestic Visitors, this mega event would include knowledge sessions, seminars and conferences, CEO roundtables, B2B & G2G meetings, besides strategic investment announcements, product launches and collaborations that would redefine the textile industry on a global scale. Live demonstrations, cultural events, and fashion presentations will provide an exceptionally creative and engaging environment, providing insights into the realms of textile, fashion, sustainability, and style originating from the heart of India. Designer as well as brand exhibitions, fashion shows, sustainability workshops and expert talks shall be the other highlights of the event. Bharat Tex 2024 is being planned as a consolidated and unique platform to position and showcase India's entire textile value chain and also highlight strengths in



fashion, traditional crafts and sustainability initiatives. Bharat Tex 2024 would be a comprehensive showcase of the entire textile industry value chain from India's rich cultural heritage and textile traditions to the latest technological innovations.

Smt Rachna Shah, Secretary, Ministry of Textile said that there is a huge opportunity for Textile industry to increase its exports and hence Bharat Tex 2024 comes at the right time. It would not be just an exhibition, but an immersive experience. The expo would also represent a unique platform for global investors and buyers to explore India's strengths as a global manufacturer and consumer market.

The event is an industry led initiative and is proposed to be organised jointly by the 11 Textile related Export Promotion Councils (EPCs) and other industry bodies. Shri Naren Goenka, Chairman Apparel Export Promotion Council (AEPC) and Shri Bhadresh Dodia, Chairman Manmade and Technical Textiles Export Promotion Council (MATEXIL) made detailed presentations on the activities proposed in the fair.

The Council participated in the 'Investment and Trade Promotion' Roadshow in South Korea organised by Dept. of Commerce with support from the Embassy of India in South Korea. The Roadshow was held from 16th to 18th October, 2023, under the lead of Secretary DPIIT (Dept. for Promotion of Industry and Internal Trade), Shri Rajesh Kumar Singh with an aim to promote India as an attractive investment destination and to promote Indian products in Korea.

The Delegation included representatives from various Organisations & Line Ministries like Ms Shubhra, Trade Advisor, Ministry of Textiles; Mr. Rajat Kumar Saini, CEO & MD, National Industrial Corridor Development Corporation; Mr. Jitendra Kumar, Director, Ministry of Food Processing Industries; Mr. Gaurav Joshi, Deputy Secretary, Ministry of Heavy Industries (Auto); Mr. Sagar Sharma, Chief of Staff, India Semiconductor Mission (ISM), Ministry of Electronics & Information Technology; Mr. Pramod Kumar Tiwari, Director General, Bureau of Indian Standards (BIS) and Invest India.

Besides the line Ministries, EPC representations were from Apparel Export Promotion Council and Texprocil. There were exporters from Textiles (2), Apparel (2), Food Industry (3) and Pharmaceuticals (3) that also participated in the delegation. Many exporters who had registered had to drop out due to nonavailability of visa.

The delegation visited Seoul (16 & 17 October) and Busan (18 October). The Council along with the Trade Advisor, MoT and AEPC also visited Daegu on 19 October.

On 16th October, in the first half there was a Press Briefing wherein the Ambassador and Secretary, DPIIT briefed the Korean media representatives on activities being planned during the Roadshow.

The Press Briefing was followed by a Seminar on Investment & Trade Opportunities. While introducing the delegation to the Korean audience, the Ambassador of India to Korea, H.E. Shri Amit Kumar mentioned that 2023 marked 50 years of bilateral relationship between India and Korea and a widening and deepening of the India - Korea CEPA was very essential. Besides political and strategic issues, he highlighted that benefits need to be taken from many start-ups in the science as well as technology space. India is a growth story as it is a \$3.5 trillion economy growing at 6%. He also said that almost 600 Korean companies are currently doing business in India while India is also investing in the UPI and digital space, green energy solutions and deployment of solar energy.

Later presentations from all line ministries like Textiles, Electronics, Heavy Industries (Auto), BIS, Invest India and DoC

'Investment and Trade Promotion' **Roadshow in South Korea**



were made on Investment Opportunities & New India's Growth Story. During the second half of the day, there were trade meetings for the Pharma exporters organised by the Embassy.

On 17th October, an investment session was organised for the Textile Sector which was chaired by Secretary DPIIT. Textile companies like Haensoll, Global Sae-A Group, J2LFA, KOFOTI, Hansae, Taekwang including a footwear company that manufactured for NIKE etc were present in the meeting.

One of the major issues that came up was that Korean companies are ready to invest in India but big companies who have already invested are facing many issues. Secy DPIIT mentioned that these issues would be taken up and resolved at the earliest. A couple of companies are likely to invest but their research on labour (on wages and relevant skill sets) and environmental conditions are still on.



In the afternoon business session, Ms Shubhra, AEPC and Texprocil made presentations on the textile industry and also on the textile Mega Show 'Bharat Tex'. The Texprocil presentation

also included information and updates on Kasturi Cotton and the General Certificate of Conformity (GCC) Program. The audience were made aware of the new premium cotton which was launched by India and the initiatives of the Council for traceability and certification of Indian farm cotton through the GCC program. There were about 8 Korean companies (with multiple representatives) that attended the B2B Session. Companies interested in organic cotton and high quality cotton and blended fabrics for garments were also present and the Council interacted with them. Their enquiries have been circulated to trade. The Council invited them to visit India as well as exhibit at the Mega Show.

On 18th October, the delegation travelled from Seoul to Busan for the morning session on trade and investment (a repeat of the program on 16th Oct at Seoul) with presentations from line ministries. Ms Shubhra. Trade Advisor. Ministry of Textiles also briefed the Korean audience on the various schemes available in India for investments like the \$40 billion outlay for the PLI scheme, the PM Mitra Parks etc. A pitch for participation in the Mega Show, Bharat Tex was also done. There were approx. 40 companies in attendance across different sectors like food, steel, textile, footwear, electronics etc.

During the second half of 18th October, the delegation comprising Trade Advisor, AEPC and Texprocil travelled to Daegu from Busan and met with (KTDI) Korea Textile Development Institute, Daegu. KTDI is one of the best R&D institute for hightech textile materials focused on the upstream textile industry and also displaying the capability of the textile industry. It is

a non-profit organization for contributing to development of the textile industry with R&D of textiles for both clothing and technical applications. These include tests & instrumental analysis; collection and distribution of up-to-date information and education for textile technology.

The activities of KTDI include developing new products especially in the technical textile segments for applications in defence, airspace, etc. using carbon, aramid and other technical fibres. They also undertake case study problems in textiles from industries and help resolve them through technical research. Ms Shubhra invited them to India for the Mega Show to participate in knowledge sharing sessions and also sign an MoU for technical textile technology transfer during the Mega Show.

On 19th October a meeting with the Daegu Gyeungbok Textile Industries Association (DGTIA), the organisers of the Preview in Daegu Textile Show in Daegu was arranged. Daegu is one of the largest clusters of woven fabric manufacturing in Korea and many of them are involved in developing high quality finished

woven fabrics for apparel. The DGTIA was made aware of the developments in the Indian cotton textile industry viz. the Kasturi and the GCC Progams and they were also invited to source as well exhibit in the Bharat Tex Show.

The visit of the delegation gave an insight into the current interest of the Korean companies of investing in India. Even though some of the companies have had certain issues in setting up their businesses in India, there is still an active interest



among the other companies provided more clarity is available in terms of labour, fast approvals etc. The Korean companies have also reaped higher benefits and gains by their investment in India compared to their parent locations.

According to the quick estimates data released by the Ministry of Commerce & Industry, exports of cotton yarn fabrics/made-ups, handloom products etc from India grew by 27.39% in September 2023 over September 2022.

Central Banks Take Center Stage in a Pivotal Week for Global Markets

"Central Banks Take Center Stage in a Pivotal Week for Global Markets"

As the financial stage is set for a high-stakes spectacle, the forthcoming monetary policy meetings of major central banks promise a narrative of suspense and intrigue. The Bank of Japan took the spotlight on October 31st, followed by the Federal Reserve on November 1st and the Bank of England on November 2nd. In this unfolding drama, the decisions made in these critical moments hold the power to dramatically sway global markets, casting a shadow of uncertainty or heralding a new era of economic dynamics. Brace yourselves for a week that could redefine the pulse of international finance.

Bank of Japan's monetary policy outlook:

Speculation is growing regarding potential policy shifts by the Bank of Japan (BOJ) as it grapples with a weak yen, increasing bond yields, and unexpectedly robust inflation. The upcoming monetary policy meeting concluding on October 31 has attracted attention, with discussions centering on adjustments to the BOJ's yield curve control program. A recent report from Nikkei has fueled expectations, but divergent views among officials introduce uncertainty. Governor Kazuo Ueda, confronting challenges of surpassing inflation targets and a vulnerable yen approaching the 150-mark against the dollar, has implemented unconventional actions. The yen's volatility is raising concerns about potential currency intervention. The market anticipates possible BOJ intervention in response to the yen's weakness, potentially reaching 150 levels. Yields on Japanese 10-year bonds reached a decade-high of 0.855%, nearing 1%. The BOJ can intervene to control yields, but these risks push the yen lower, complicating the delicate balance between stimulus measures and currency stability.

In conclusion, the upcoming BOJ meeting is pivotal. Governor Ueda navigates a complex landscape of inflation, yields, and currency dynamics. Market participants eagerly await clues about the BOJ's strategy to address these economic challenges. If the Bank of Japan shifts away from its current ultra-loose monetary policy, there is a likelihood of the Japanese Yen appreciating, possibly reaching the 148 levels in the near term.

Federal Reserve's Monetary Policy Outlook:

Despite strong economic indicators, Powell emphasizes caution, pointing to uncertainties both globally and domestically. After keeping rates steady last month, the Fed suggests a likely halt in rate increases for upcoming meetings. The recent rise in longterm treasury yields suggests a potential impact on future rate decisions. Core inflation continues to exceed the 2% target, requiring sustained evidence of a downward trend. While acknowledging positive economic data, such as robust retail sales and PMI figures concerns short-term inflation volatility. Also signs of a cooling labor market and heightened geopolitical tensions as risks that deserve attention. The recent increase in yields to 5% is attributed to a rise in term premiums. The Fed remains committed to achieving the 2% inflation target, with future tightening contingent on unfolding economic developments. According to the Fed's monetary tool, the current probability of a Fed rate pause is 96% for November and 70% for December.

In conclusion, Powell's remarks suggest a cautious and datadependent approach to future monetary policy decisions. While signaling a likely pause in interest rate increases for the upcoming meetings, the Fed remains vigilant about evolving economic conditions, inflation dynamics, and potential risks. The central bank aims to strike a balance between supporting economic growth and managing inflation expectations, emphasizing a commitment to achieving its policy objectives. Leading up to the FOMC meeting, a decrease in the DXY can be anticipated, potentially reaching 105.5 levels, attributed to the diminishing probability of a rate hike. Whereas any unexpected hawkish comments will lead to a momentum towards 107.30 levels, however, the probability of the same is negligible.

Bank of England's monetary policy outlook:

The Bank of England (BoE) is expected to maintain its Bank Rate at 5.25% in the upcoming November 2 meeting, as per the consensus among economists. Despite September's inflation reaching 6.7%, an immediate rate change is not anticipated. The persistent inflation above the 2% target has prompted a prudent approach. The market foresees a possible rate cut not before July 2023, with a median prediction of a 25-basis point reduction in Q3. Inflation is expected to gradually decrease but may not reach the target until Q2 2025. While a recession is not the baseline scenario, the economic outlook appears weak. Projections indicate a contraction of 0.1% in the last quarter, with stagnant growth expected in the current quarter and only marginal growth of 0.1% in the first two quarters of the next year.

In conclusion, the BoE's monetary policy remains cautious, with a focus on inflation trends and a potential rate cut in mid-2023. The economic outlook suggests slow growth, with recession risks on the horizon but not immediate. With the possibility of a higher for longer stance from BOE, we anticipate an upward correction in the GBPUSD towards 1.2350-1.2400 levels. On the flip side, support for the pair lies near 1.21-1.2050 levels.

As global markets hold their breath, the upcoming central bank meetings set the stage for a week of economic revelation. From the Bank of Japan's carefully calibrated response to inflation and currency stability to the Federal Reserve's cautious stance amid uncertainties, and the Bank of England's watchful eye on persistent inflation, the financial world braces for pivotal decisions that could reshape the international economic landscape. Stay tuned for a week that may redefine the pulse of global finance and set the tone for the months to come.

How has Indian Rupee fared so far in 2023.... And what future does it hold for 2024?

In 2023, the Indian Rupee displayed resilience compared to its depreciating movement in 2022. During the first half of the year, the currency traded within a range of 81.60 to 83.05. The RBI was observed accumulating reserves near the bottom

of the range and absorbing flows. Simultaneously, when the Rupee was depreciating towards 82.80-83.00 levels, the RBI intervened to curb the sudden fall. On the global stage, Banking crisis in March was the major impactful event apart from Fed rate hike. Despite these, the Rupee's momentum remained relatively stable, but due to narrowing the interest rate gap, premiums fell to nearly a 12-year low.

The second half of the year was notably quieter specially after September, with the daily 14-period Average True Range hitting a low of 13 paise, a level not seen since 2004. After September, the USDINR pair remained above the 83 mark, seldom crossing 83.40 on the higher side. On the major event side, Fitch's US credit downgrade in August, and geopolitical tensions between Israel and Palestine impacted a bit to US Dollar, however, momentum in Rupee remained very much limited. May be, RBI too pegged a currency in 83-83.40 range, through intervening in spot, forwards and futures. On the economic data side, inflation briefly exceeded the Central Bank's range but was swiftly curbed within a couple of months, reaching multi-month lows. Furthermore, both manufacturing and services PMIs outperformed global PMIs. On the growth side, India achieved a GDP rate of 7.6% in Q2 FY24, leading the RBI to revise India's GDP growth target to 7% for FY24, up from the earlier forecast of 6.5%. Regarding fund flows, unlike the previous year's outflow of Rs. 1.32 lakh crores from FPIs, this year experienced significant inflows of 1.88 lakh crores. This surge led the Nifty to reach an all-time high above 21,000 and the Sensex to touch 70,000, resulting in an overall market capitalization of \$4 trillion, achieved in less than 3 years, adding \$1 trillion.

Looking ahead, the market will pivot around three key themes: a potential US rate cut (expected in March or May), and the upcoming India General Election scheduled for May 2024.

Following a decline in October's inflation figures and a dovish speech from a Fed member, the market began speculating about a rate cut in 2024. Within just a month, the market started factoring in a rate cut of almost 150 bps. By the beginning of December, the market also began expecting rate cuts from the ECB and BoE. However, we believe that despite declining inflation in Europe, the ECB may not be able to cut rates due to an additional challenge- a significant disparity in inflationary pressures among EU member states, known as the fragmentation issue. This issue complicates swift changes in the ECB's stance when considering rate hikes or cuts.

Regarding the BoE, a 2% fall in inflation might be short-lived, and they might be the last among their peers to opt for a rate cut. Overall, we anticipate that the Fed will likely be the first and most impactful in cutting interest rates among its peers, potentially affecting the USD. We project that the DXY, currently trading near 104, may decline towards 100 and below in 2024. A decrease in the dollar's value could have a positive effect on the Rupee, and we anticipate that next year, this trend will likely manifest in the local currency.

The second pivotal theme, the **General Election in India**, has historically triggered significant inflows. **In the past two General Elections (2014 and 2019), noteworthy inflows of \$15.53 billion and \$11.98 billion respectively were observed from January to May.** Recent state election outcomes, indicating victories for the BJP in three major states, have raised expectations for the BJP's potential third consecutive win in the general election. Such an outcome might attract flows, mitigating policy shift risks and potentially bolstering the Rupee.

Outlook:

In summary, domestic fundamentals seem robust, and the expectation of a global rate cut favors the Rupee. Consequently, there is a higher likelihood that the Rupee may not depreciate

toward the 83.50-84.00 zone but could appreciate toward 82.50-82.00 over the next 3 to 5 months. Furthermore, we believe that the Rupee is likely to continue trading in the same range throughout 2024.

Additionally, the Ministry of Textiles introduced the Kasturi Cotton program, a premium certified quality cotton with traceability. TEXPROCIL, in collaboration with CCI on behalf of the Ministry of Textiles, is overseeing the implementation of this program. All ginners in the country are empowered to produce Kasturi Cotton following quality protocols.

In conjunction with CCI, CAI, and CITI, the Ministry of Textiles unveiled the event brochure for the 81st Plenary meeting of the International Cotton Advisory Committee (ICAC), slated to take place in Mumbai from December 2nd to 5th, 2023. The theme for this event is "Cotton Value Chain: Local Innovations for Global Prosperity," with over 400 delegates and observers expected to attend from more than 27 countries.

Ms Prajakta L Verma, Joint Secretary, Ministry of Textiles, set the context and purpose of holding this event on this historical day of World Cotton Day. She highlighted India's unique position as the only country with a complete cotton value chain and immense potential for increasing cotton production. She urged all stakeholders to collaborate to elevate the cotton textile industry to become a leading producer of quality textile products globally.

## Textile industry crisis looms large as demand hits a low

While inflation in buying countries and huge inventory with retailers are said to have dampened orders, multiple issues such as escalating input costs and stringent quality control orders are said to retard the Indian textile and clothing industry

Sivakumar, who operates a foundry in Coimbatore in Tamil Nadu, usually buys scrap from the southern districts of the State. However, recently he received 250 tonnes of scrap from a textile mill that had sold its machinery in Salem, a textile centre which is just a 3.5-hour drive from Coimbatore.

Similarly, in the powerloom cluster of Somanur in Tamil Nadu, Kandasamy, a weaver, says more than 10 looms are being sold away every month at his village (Devarayapuram) alone.

With such reports abound from clusters in T.N., J. Thulasidharan, president of the Indian Cotton Federation (ICF), says the current distress in the textile and garment industry, which is predominantly part of the MSME sector, is similar to the situation in the late 1960s.

#### **Factories shutting**

In the past couple of months, many factories across the textile value chain have either shut down and disposed of machinery or sold excess lands to stay in business; working hours have been reduced for labourers, impacting their wages; and the share of textiles and apparel in the Index of Industrial Production has shrunk.

In Andhra Pradesh, P. Koti Rao, who heads the A.P. Textile Mills Association, says 8-9 mills have closed down and more are on the verge of closure.

"It [textile mills] is a first generation industry in Andhra Pradesh. We used to export 30% of the yarn produced. Now, it is not even 5%. Cotton prices are high, electricity charges are up, and there is no support from the Centre or State governments," he says. An oft-repeated cause for the crisis is that the industry is going through a prolonged period of low demand in both export and domestic markets.

The domestic demand is tepid though retail sales during the festival season this year was on a par with that of last year.

On the export front, shipment of textiles declined 0.41% in April-October 2023, compared with the same period last year even as it grew 24.29% in October 2023 as against October 2022.

Apparel exports saw an 8.08% degrowth in October and declined 14.58% in April-October 2023 compared with the same period last year.

#### **Apparel shipments fall**

Apparel shipments started declining last August, looked better in November and December 2022, but started registering negative growth again since January this year. The geopolitical situation, inflation in buying countries, and huge inventory with the retailers are said to have dampened orders. But, for the Indian textile and clothing industry, there are multiple issues stunting its growth and competitiveness — raw material prices, escalating input costs, quality control orders (QCO), and import of garments, to name a few.

Raw material (fibre) constitutes 60-70% of manufacturing cost, which has turned expensive in India impacting the competitiveness of the industry severely, says S.K. Sundararaman, chairman of the Southern India Mills' Association. "Cotton prices crossed ₹1 lakh a candy in the last before season (2021-2022) and still textile mills were buying. Now, cotton prices are less than ₹60,000 a candy and there are no buyers," said an official source.

The Indian textile sector is largely cotton based and production and yield of cotton in the country are on a downward trend.

In 2013-2014 cotton season, production and yield peaked to 398 lakh bales and 566 kg a hectare respectively.

In 2021-2022, the actual production was 310 lakh bales and yield 451 kg a hectare. Imposition of 10% import duty in 2021 led to a sharp rise in cotton prices that year and then a fall from last October, hurting farmers and the industry.

"Any decision of the government should be consistent and long term, benefiting farmers and the consumer industry. For more than a decade from 2008, India did not have import duty on cotton," points out Nishanth Asher, secretary of ICF. At the present price levels, Indian cotton is on a par with the world average. Only if it stabilises at this level, can the industry make gains.

In the case of man-made fibre (MMF), domestic supply is limited and introduction of QCO is hurting the industry, say sources.

The average capacity utilisation of the textile industry in Gujarat is 70%, says Ashish, a weaving unit owner. "We used to import almost 20% of filament yarn. Now, we cannot because of the QCO. In the last two months, yarn price has increased by ₹5 a kg," he adds.

Mr. Ashish and Sanjay Jain, another textile exporter, feel the government should have introduced QCO on garments and fabric instead of fibre. While there are restrictions on import

of fibre, fabrics and garments are coming in mainly from Bangladesh.

Between January and September this year, fabric, apparel and home textiles worth \$3,247.6 million were imported. Total textile imports during this period stood at \$6,967 million.

Palanisamy, who manufactures undergarments in Tiruppur and and sells them in the domestic market, says, "A buyer from Kerala recently showed me a piece made in Bangladesh. It costs ₹25 while my product costs ₹30. Branded retailers are opening outlets in smaller towns too and they sell a lot of imported garments," he says.

According to Rahul Mehta, chief mentor of the Clothing Manufacturers Association of India, "Those who compete on prices are affected the most because of imports. With Bangladesh having duty-free access to Indian market, those garments are available at 15-20% less cost in India."

When fabric is imported, jobs are lost in cotton, spinning, knitting, compacting, and processing segments in India. So, on the lines of the 'Make in India' campaign, the government should encourage purchase of Indian textiles. While the current volume of imports are not much compared with the overall size of the domestic market, diversion of these orders to local manufacturers will bolster production, say industry sources.

In the international market too, Indian garment exporters continue to face price challenges. Buyers are cost conscious and despite the recent hike in wages in Bangladesh, Indian exporters do not expect major shift in orders. The overall cost difference between Indian and Bangladesh garments should be about 2-3%, but the labour costs are lesser in Bangladesh by almost 30%. With Bangladesh having duty-free access to the

EU, Indian exporters are unable to make inroads.

Post the first wave of COVID-19, there was a huge demand and prices started moving up across the supply chain. This buoyed the domestic industry and capacities were added rapidly. With some of the States also offering incentives and packages to attract investments in textiles, there is over capacity in many segments. "Subsidies cannot continue for long and costs of labour or electricity will increase. The industry should work out the metrics to improve its competitiveness," said Siddhartha Rajagopal, Executive Director of Cotton Textiles Export Promotion Council.

In clusters like Tiruppur, where the mainstay of the economy is the textile industry, rentals, retail sales, and restaurants are also bearing the brunt. "My godown has no takers for almost a year now," said Sakthivel, a realtor. Muthupandi used to stitch 1,000 pieces of garments a day at an export house, earning 50 paise for a piece. He now gets only 50% of the work. "Even the money to buy tea is given only as an advance amount to workers," he says.

The industry continues to hope for a revival in demand and the harbinger for that are cotton textile exports. Export of cotton yarn, fabrics, made-ups and handlooms is witnessing signs of revival since July this year, with outbound shipments crossing pre-COVID levels in October 2023.

"Cotton textile exports are normalising and home textiles are expected to lead the growth," says Mr. Rajagopal.

But, what the industry needs urgently is policy intervention at the Centre and State-levels and holistic measures to improve competitiveness.

## TEXPROCIL to use blockchain tech for certifying Kasturi cotton



The Cotton Textiles Export Promotion Council has rolled out a blockchain-based technology to enable traceability of garments and fabrics made of Kasturi cotton using QR code.

The government has appointed Cotton Corporation of India and TEXPROCIL as the nodal agency to promote Kasturi as the premium cotton brand from India.

TEXPROCIL has registered 300 ginners on its platform that certifies the premium 29-30 mm cotton with trash content of 2 per cent and other defined matrix. The Kasturi cotton will fetch a premium price of 5-6 per cent for farmers.

Lalit Kumar Gupta, Chairman and Managing Director, CCI, said the industry expects an output of 300 quintals of Kasturi cotton in the first year of production.

The quantity will increase in the coming years as the farmers realise the benefit of growing cotton that meets the specification to be branded as Kasturi cotton, he added at the event to announce the 81st plenary meeting of the International Cotton Advisory Committee in Mumbai.

#### Brand promotion

Roop Rashi, Textile Commissioner, said the event which is themed as "Cotton Value chain: Local innovations for global prosperity" would serve as a platform for sharing good practices and experiences across the globe on productivity, climate resilience and circularity for a vibrant cotton economy.

In a bid to promote Kasturi cotton among global audience, she said textile minister Piyush Goyal will launch a logo and stamp of the cotton brand Kasturi.

Siddhartha Rajagopal, Executive Director, TEXPROCIL, said CCI will identify the farmers who want to sell cotton that meets Kasturi specification and the Council will certify the cotton bales after doing the due diligence.

Once the cotton is certified, a specific QR code will be generated and it will be updated as it changes hands from ginners, spinners and weavers. The final garment made of Kasturi cotton will have a QR code which can be used to trace back the ginner, he said.

Going ahead, he added there are plans to register the farmers who sell Kasturi cotton so that the tracking can be from field to garment.

#### **Create Maximum Awareness**

- Ginners & Spinners should register in large numbers on this platform and actively promote the Kasturi Cotton Bharat program.
- Need to make follow-up meetings with the ginners & spinners.

Need to create Kasturi Cotton Bharat program flyers of the process in the local language.

#### At the Farm level

- Visits to the cotton fields are necessary to provide the awareness trainings to the FPO/Farmers on the fields on good picking/harvesting practices.
- We should encourage the farmers for mechanized picking of kapas using hand-held plucker.
- Broad category of distinction to be done, heap picking to be practiced on field to get the uniformity in the final raw cotton bales.

#### **Ginning Process**

- Heaping to be done separately as per the kapas arrivals at ginning unit.
- Ginners should avoid mixing of multiple farm origin kapas and low quality kapas while preparing of cotton bales.
- Minimise and controlling of contamination to avoid drastic loss.

#### **Spinning Process**

By using the kasturi cotton while preparing the yarn at spinning unit there is an extreme transformation in the efficiency.

- Kasturi Cotton uniformity is one of the most significant factor apart from all other parameters.
- In case of any difficulty in production of Kasturi Cotton Bales, if needed, experts from Kasturi Cotton team (including himself) can visit with the specific Ginning unit and guide them on how to prepare the Kasturi Cotton Bale lots.

#### • Assuring Quality

- Preparation of heap picking & storage needs to be practiced by the ginners, if heap picking & separate storage is not practiced, then both the cotton i.e. good quality & low quality cotton get mixed together to form a contaminated lot.
- Proper kapas buying is done & proper heap segregation to be maintained as per the farm arrival.
- The heap wise examination to be performed by the



ginner's procurement team for various parameters set for Kasturi Cotton.

- Enhancing Value
  - Good, average, thorough picking, Heap wise pre-clearing & post-cleaning to be done.
  - Maintaining the Uniformity of cotton will enhance its value.
  - In the current competitive market, to sustain and create preference for the goods, then only the ginners can get the premium for their cotton bales.

After this session, a presentation was made by Mr. Udaysinh Kharat (Project Head – Kasturi Cotton Bharat) followed that centered around fostering awareness about Kasturi Cotton Bharat, its unique qualities, and its impact on the textile industry. Participants engaged in productive conversations, shared insights and ideas for the promotion of Kasturi Cotton in the region. The following points were actively discussed during the session;

Introduction on "Kasturi Cotton Bharat" program & the role of Texprocil as an Implementing Agency:

- The Kasturi Promise & benefits of using 'Kasturi Cotton' in Supply Chain.
- Program Structure (Implementation of Branding, Traceability & Certification)
- Packing, marking Inspection with Sampling & Testing process:
- Quality Standards of Fiber to qualify as Kasturi Cotton.
- Registration process of Supply Chain units (Cotton Trading, Ginning, Spinning, Processing and Garmenting/Finished Goods Unit)
- Kasturi Cotton Supply Chain traceability using Blockchain.

A) Amnesty Scheme - Closure of cases of default in EO under AA/EPCG Schemes where applications have been filed with PRC/EPCG Committee for relaxation in policy/procedure on grounds of genuine hardship/adverse impact on trade

DGFT vide its Trade Notice No.35/2023-24 dated 5.12.2023 has informed the concerned exporters the following:

- PRC/EPCG Committees consider each application based on individual facts and circumstances on a case-to-case basis.
- Since Policy relaxation is not a matter of right, all such authorisation holders need not wait till their requests are decided by the PRC/EPCG Committees and submit their applications for closure of default in EO under the Amnesty Scheme by 31.12.2023.
- Pendency of any application for relaxation/ clarification would not form a ground for relief/ extension of permissible time period for filing of applications beyond 31.12.2023.
- Last date for filing applications under the Amnesty scheme will not be extended beyond 31.12.2023.

B) Pilot Launch of the Upgraded Electronic Bank Realization Certificate (eBRC) system for selfcertification by Exporters

The enhanced eBRC system is designed to reduce transaction time / costs as well as to ease the burden on bankers. This system is a more streamlined process based on electronic Inward Remittance Messages (IRMs) to be transmitted directly by banks to DGFT. Based on the IRMs received, exporters shall self-certify their eBRCs. The new eBRC system has been launched in a pilot phase on 15.11.2023. All banks will execute the transition to the new system by 31.01.2024. In this regard, DGFT has issued Trade Notice No.33/2023-24 dated 10.11.2023.



- At the end, the application needs to be signed digitally by DSC or Aadhar e-sign.
- After signing of the application, the payment of renewal subscription needs to be done and click on 'Submit' to submit the application.




