CHAIRMAN'S MESSAGE



Dear Friends, As I write this last column as Chairman Texprocil for this Newsletter a whole host of

memories flood the mind.

It has indeed been a matter of great privilege to have served as Chairman of an august industry body which has been at the forefront of promoting exports of cotton textiles for over six decades.

During the last two years, I have had the opportunity to be part of exciting efforts at accelerating the wide ambit of activities at TEXPROCIL, be it representing the demands of the members to address various issues of policy and procedure so as deliver competitiveness and in turn raise the country's market shares, or responding instantly to the agenda of reforms the Government is serving up to the trade and the industry. Each day has been memorable as we devised strategies for promoting the cause of Cotton Textiles across various countries around the globe.

As we reflect on the two years gone by, I must thank each and every individual – the Government Officials, Fellow Exporters, other apex textile bodies and Our secretariat, ED and his team of officers and staff who have made the following significant achievements possible:-

Firstly, we have been able to get almost all categories of Fabrics and Madeups covered under the MEIS which I am sure has improved our competitiveness in the export markets. Secondly, we have been able to successfully persuade the government in retaining the entire cotton textile value chain under the 6 per cent optional central excise duty structure. If included under the mandatory excise duty structure it would have severely hampered the functioning of the industry.

Thirdly, with regard to Incremental Exports Incentivisation Scheme (IEIS) for the last quarter of 2012-13, the government had restricted the entitlement to exporters at 25 per cent growth or incremental growth of Rupees Ten Crores. whichever less. I am glad that the government has, recently, removed this restriction and the exporters are now able to get full entitlement against incremental growth in exports.

CHAIRMAN'S MESSAGE

As you are all aware, ever since the simplification of the schemes under the new government with the introduction of Merchandise Exports from India Scheme (MEIS), the Council has been making repeated representations to include many of our products and markets under the purview of this Scheme. These efforts have yielded positive the Government results with giving due consideration to our representations. For example, the exports of madeups to the markets of Australia and New Zealand have now been included under the MEIS.

I am aware that while we have succeeded in resolving many of the issues affecting our competitiveness, there remain a few unfinished tasks which I hope my successors will strive to accomplish. Despite our best efforts we have been unable to get the Government agree to extend the MIES benefit to cotton yarn. Similarly, we have not been able to persuade the Government to extend the benefit of interest rate subvention to Cotton Yarn and to the Merchant Exporters.

Hopefully, Government will see reason in the coming days and extend these benefits to these sectors.

Apart from this, we are grateful that the Drawback Committee under the Chairmanship of Dr. Saumitra Chaudhary has been considering most of the proposals put forth by the Council. Many issues under the Drawback Scheme including rates, caps, etc., have by and large been resolved.

I am also fully aware of the day to day operational issues faced by the exporters at the Customs, Regional Offices of the DGFT, Ports etc. The Council has been taking up all such issues from time to time with these Departments. I am glad that most of the issues and concerns have been addressed. Many of these Departments are now responding promptly to representations submitted by the Council.

The Council's wide ambit of activities in organizing Fairs, BSMs, and visit of Trade Delegations has led to optimal use of financial and time resources to enhance the country's exports.

The ISO Certification that was received by the Council at the time of my predecessor has been renewed till September 2017. I must place on record the sincere efforts of the Council's Staff & Officers who rose to the occasion & willingly continued to adhere to the ISO norms. Recently, the Council held its Awards Function on 21st of October celebrating excellence in Exports. The grand function held at Hotel Trident in Mumbai saw the Hon'ble Minister of Textiles Smt Smriti Zubin Irani as the Chief Guest along with Dr. Kavita Gupta, Textiles Commissioner as the Guest of Honour presiding over the event. The award winners received a grand felicitation for their sterling performance which has earned them the richly deserved awards.

During the interim period we have also undertaken a comprehensive review of the promotional campaign of the Council which was unveiled by the Hon'ble Minister of Textiles, Smt Smriti Zubin Irani at the TEXPROCIL Award function in Mumbai. As a part of the campaign, we have introduced the new look promotional material comprising brochures, flyers, mailers bringing out the feeling of luxury of cotton textile that inspires all of us, owing to its natural properties.

At the Council, it has always been our endeavor to look at developed as well as emerging markets as export destinations for cotton textiles.

Towards this end, the Council has drawn up a comprehensive program to target new markets like Myanmar, Iran and Mexico apart from intensifying our efforts in markets like China, Colombia, Turkey and Bangladesh.

A number of studies were also commissioned by leading consulting firms like Boston Consulting Group, Ernst Young, Gherzi International, Wazir Advisors – on various aspects of textile trade including exploring the market opportunities in Africa.

I am sure that all these reports have served the objectives of sensitizing the trade and industry on the immense opportunities available to it for expanding trade.

At the same time we have succeeded in sensitizing the various Government agencies of the enormous potential of the textile industry and trade in promoting the goals of inclusive growth and higher employment.

Friends, the Council will be holding its 62nd AGM on the 21st of November. I consider it as my good fortune to preside over this meeting, marking yet another milestone in the long journey of our Council.

Although we have achieved substantial competitiveness in conversion of raw material into finished products, yet we have to travel a long distance to tide over issues that have been affecting not just India but have altered the manner in which global trade is being conducted.

Recent developments relating to the demonetising of high value currency in denominations of Rs 500 and Rs 1000 and the election of a new President of the USA on the back of a high decibel anti-globalization and inward looking campaign will present their own set of challenges requiring us to frame our strategies in many creative ways. These issues, I believe are fundamental in nature and need to be continuously addressed even as we keep looking inward to improve our levels of competitiveness.

An important initiative taken by the Ministry is the announcement of a special package for the Garment Sector. The package offers a slew of measures for labour reform & tax concessions for employment generation and enhancing exports. We have represented to the government to extend the scheme to value added Cotton Madeups as well and await announcement in this regard.

Another policy initiative is the implementation of GST which is a landmark in India's economic and taxation history.

Given the open mindedness of the government and the keenness to support the industry, we should be confident of giving the necessary thrust to the growth of the entire industry.

Friends, as I look back with a sense of satisfaction I am also aware of the fresh challenges likely to confront us as move along on our journey to achieve excellence in exports.

I believe that every problem has a solution and we should all work towards giving our best as we strive to fulfill a national duty to promote our exports.

Serving Texprocil has always been a matter of calling and duty rather a matter of pelf and privilege.

As I bow out as Chairman, I wish all our readers and members the very best in all their endeavours.

TEXPROCIL Welcomes Chinese Delegation

Purpose of the visit of CHTA delegation was to attend ITMF Conference and to meet with leading home Textile manufacturers in India to discuss business opportunity for mutual benefit.

The delegation visited the manufacturing facilities of Alps Industries, Birla Century and Trident Industries. During the factory visits and interactive meetings with these companies, the Chinese delegation showed keen interest to understand cost components in manufacturing of certain varieties of value added home textiles and possibility of business tie-ups. Some of the members of the delegation were large scale retailers having their own brands popular in China.

These companies are exploring possibility of sourcing certain varieties of bedlinen and curtains from India and sell in China with their own brands. Two of the delegates have extended their stay to meet with more number of large manufacturers in India.

Chances are bright that some of these delegates would import home textiles from India in the near future.

Some of the members of the delegation from the group were keen to source cotton yarn and value added home textiles from India, while others were looking forward to visit India again to undertake in depth business discussions and possible trade negotiations.

Way forward

Bilateral trade with China accounts for a trade deficit of US\$ 53 billion which is almost 45 per cent of India's aggregate trade deficit. With India already accounting for 35-40 per cent of China's requirements of Cotton and Cotton Yarn, the Textiles sector can contribute to reduction of the trade deficit. Trade facilitation in its own way towards the strategic approach that India needs devise in our dealings on trade with China.

Members may note that the eligibility criterion of annual export turnover is minimum Rs. 2 Crore. Those not fulfilling the criteria will automatically be renewed as RTE i.e. Registered Textile Exporter.

RTEs are not required to submit the CA certificate.
