Sub: Inviting participation at Yarn Expo & Intertextile Shanghai Apparel Fabrics Fairs, Shanghai, China, 25th to 27th August, 2026

The Council proposes to organize an India Pavilion at 'Yarn Expo' & 'Intertextile Shanghai Apparel Fabrics' being held from 25th to 27th August, 2026 in Shanghai, China.

About Yarn Expo & Intertextile, Shanghai

Dates: 25th to 27th August, 2026 [3 days]

Venue: National Exhibition and Convention Center (Shanghai), China

No. of Exhibitors at Yarn Expo Autumn 2025 edition: 580 exhibitors from 16 countries and regions. No. of Visitors at Yarn Expo Autumn 2025 edition: Over 22,000 Trade Visitors.

No. of Exhibitors at Intertextile Shanghai Apparel Fabrics in 2025 edition: 3,700 exhibitors from 26 countries and regions.

No. of Visitors at Intertextile Shanghai Apparel Fabrics in 2025 Autumn edition: Over 100,000 Trade Visitors.

Yarn Expo & Intertextile Apparel Fabrics Fair, Shanghai is the meeting point with importers visiting from all over the world. Member exporters of the Council reported a very encouraging response during the March 2026 edition.

Participation Fee:

Two separate invoices will be raised and payment has to be made separately:

1. Yarn Expo

a) Participation fee for a 9 sqm standard shell scheme booth - Rs. 3,30,000/-

b) Management fee - Rs. 16,275 plus Rs. 2,929.50 (18% GST) = 19,205 (rounded off)

c) Management fee – Rs. 41,275 plus Rs. 7,842.25 (18% GST) = 49,117 (rounded off) for a CORNER booth

2. Intertextile Shanghai Fabric Apparel Show/Denim Pavilion

- a) Participation fee for a 9 sqm standard shell scheme booth - Rs. 4,90,000/-
- b) Management fee - Rs. 18,725 plus Rs. 3,370.50 (18% GST) = 22,096 (rounded off)
- c) Management fee – Rs. 43,725 plus Rs. 7,870.50 (18% GST) = 51,596 (rounded off) for a CORNER booth

3. Accessories Hall

- a) Participation fee for a 9 sqm standard shell scheme booth - Rs. 4,00,000/-
- b) Management fee - Rs. 14,675 plus Rs. 2,641.50 (18% GST) = 17,317 (rounded off)
- c) Management fee – Rs. 39,675 plus Rs. 7,141.50 (18% GST) = 46,817 (rounded off) for a CORNER booth

Larger stands in multiples of 9 Sq. Mtrs. at proportionately higher fee will be considered subject to availability according to floor plan.

Corner Booth: Since limited corner booths will be provided, allotment will be strictly on “First Come First Serve” basis on receipt of full payment and application.

Sharing of booths is strictly prohibited.

Participation fee includes: Standard built up Booth includes: 3 lights, 1 Waste basket, 1 Power point Socket, 1 Round Table, 3 White Meeting Chair, 3 Shelves / Racks, 1 lockable info counters, wall to wall carpet, name fascia, Brand India promotion,

Please note that this fee does not include Airfare, Hotel expenditure, dispatch of display material and other related expenditure.

The participation charges are refundable only in case of cancellation of trade fair by the fair organizer.

Note: The Council has proposed participation of the event under the Market Access Support Scheme under Export Promotion Mission, however, we have not yet received approval for this event. In case the approval is granted subsequently, the applicable subsidy will be provided to the 20 eligible applicants on a ‘First Come First Served’ basis hence, please send your applications with entire participation fee immediately.
